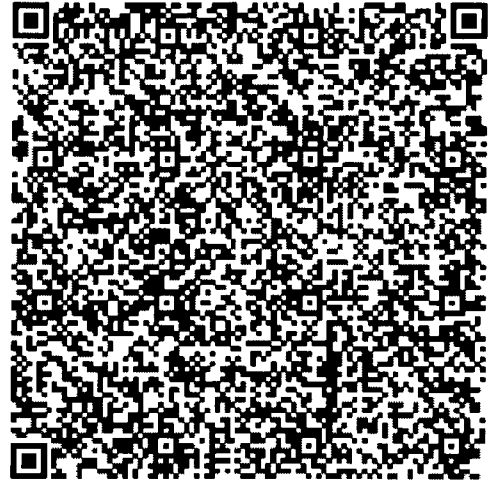

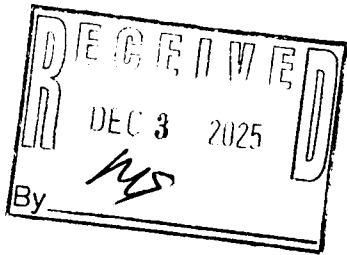

**PENNSYLVANIA'S LITTERING LAW** - As a reminder, Pennsylvania has laws against littering on our roadways and on public and private property. For any violation of Section 3709, you may be subject to a fine of up to \$300 upon conviction, including any violation resulting from the conduct of any other persons operating, in possession of or present within the vehicle with your permission, if you do not with reasonable certainty identify the driver of the vehicle at the time the violation occurred.

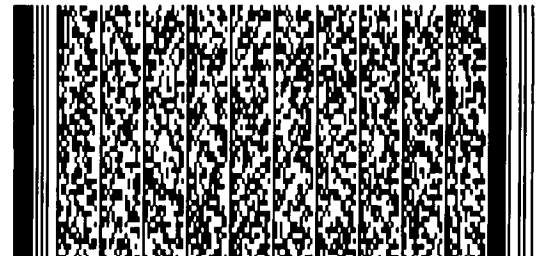
