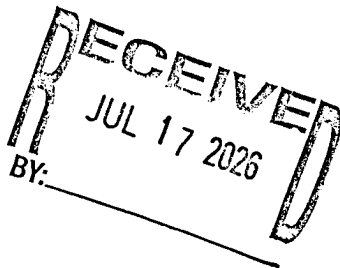

USE AVOID VEHICLE TAG AND INSURANCE PROBLEMS

When your tag expires at midnight on the expiration date printed on your Certificate of Registration.

Law enforcement may fine or cite you if you do not transfer or purchase a new tag within seven (7) business days of buying/acquiring a vehicle from a source other than a Georgia registered Dealer.

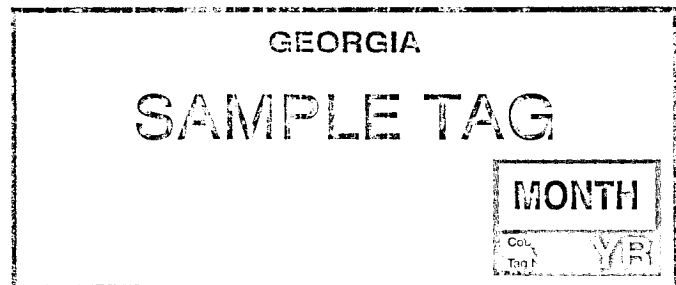
You may be ticketed by law enforcement and/or your vehicle towed if you drive with an expired or suspended tag or decal.

If you don't maintain continuous liability insurance coverage on this vehicle, you will be subject to penalties and your vehicle's registration/tag will be suspended.

A tag is issued to the owner of a vehicle. Please remove the tag if you sell or transfer ownership of this vehicle. A new owner of this vehicle may not use your tag.

When your insurance company or agent cancels this insurance for a vehicle you sell or transfer, you must cancel the vehicle's tag through your County Tag Office at the same time to avoid insurance lapse penalties.

When you sell/transfer ownership of a vehicle that is required to be titled, sign the original title to the new owner and give the title to the new owner. The new owner can apply for a title and tag in the county in which he or she lives within seven (7) business days of the sale.



- When you sell/transfer ownership of a vehicle that does not require a title, give the new owner a copy of your registration and a bill-of-sale so that the new owner may apply for a tag in the county in which he or she lives within seven (7) business days of the sale.
