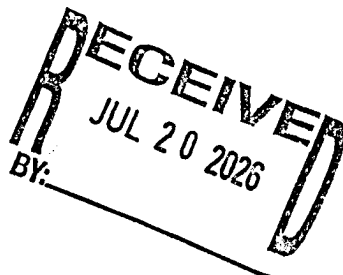

PLEASE AVOID VEHICLE TAG AND INSURANCE PROBLEMS

- Your tag expires at midnight on the expiration date printed on your certificate of registration.
- **Law enforcement may fine you \$100 if you do not transfer or purchase a tag within 30 days of buying/acquiring a vehicle.**
- You may be ticketed by law enforcement if you drive with an expired or suspended tag or decal.
- **If you don't maintain continuous, liability insurance coverage on this vehicle, you might have to pay penalties up to \$185 and your vehicle's registration/tag could be suspended.**
- A tag is issued to the owner of a vehicle. Please remove the tag if you sell or transfer ownership of this vehicle. A new owner of this vehicle may not use your tag.
- **If you sell this vehicle and get another vehicle within 30 days, apply for a title and tag transfer at your County Tag Office within 30 days.**
- When you tell your insurance company or agent to cancel the insurance for a vehicle you sell or transfer and you don't think that you will get another vehicle in 30 days, cancel the vehicle's tag through your County Tag Office within 30 days of cancelling your insurance.

- When you sell/transfer ownership of a vehicle that is required to be titled, assign the original title to the new owner and give the title to the new owner so the new owner can apply for a title and tag in the county in which he or she lives.
- When you sell/transfer ownership of a vehicle that does not require a title, give the new owner a bill-of-sale so that the new owner may apply for a tag in the county in which he or she lives.
