SECTION 316.613, Florida Statutes, requires every operator of a motor vehicle transporting a child in a passenger car, van, autocycle or pickup truck registered in this state and operated on the highways of this state, shall, if the child is 5 years of age or younger, provide the protection of the child by properly using a crash-tested, federally approved child restraint device. For children aged through 3 years, such restraint device must be a separate carrier or a vehicle manufacturer's integrated child seat. IMPORTANT INFORMATION

Section 328.42(1), Florida Statutes, requires that the certificate of registration of each vessel operated, used, or stored on the waters of this state shall be made for inspection on the vessel for which issued whenever such vessel is in operation.

Electronic titles, also called e-titles, are motor vehicle, mobile home, or vessel titles held in electronic form by the department. Electronic titles prove ownership of a motor vehicle, mobile home, or vessel the same way a paper title does. Electronically maintaining the title eliminates the risk of losing the original motor vehicle, mobile home, or vessel title. An electronic title is also an effective fraud deterrent because potential thieves will not be able to access to your title. Selling your vehicle, mobile home or vessel? For your own protection, you are required by law to transfer the title and notify the Department of Highway Safety and Motor Vehicles (DHSMV) within 30 days if you sell, donate or dispose of any motor vehicle or vessel. If you do not you could be legally responsible. Either go into a tax collector office or license plate agent with the new owner to transfer the title or go online to www.flhsmv.gov/pdf/forms/82050.pdf and download the Notice of Sale form. Fill it out, sign it and take it to the tax collector office or license plate agent for processing.
