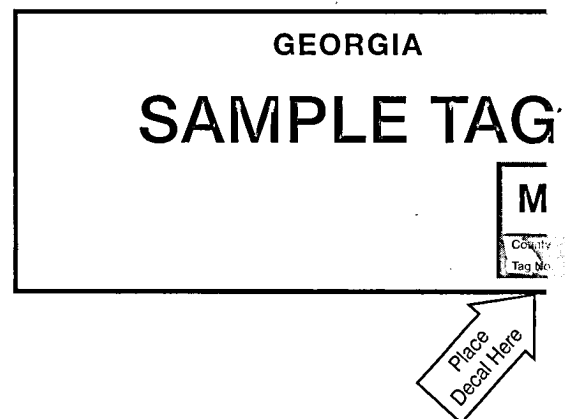

### **PLEASE AVOID VEHICLE TAG AND INSURANCE PROBLEMS**

- Your tag expires at midnight on the expiration date printed on your Certificate of Registration.
- Law enforcement may fine or cite you if you do not transfer or purchase a tag within seven (7) business days of buying/acquiring a vehicle from a source other than a Georgia registered Dealer.
- You may be ticketed by law enforcement and/or your vehicle towed if you drive with an expired or suspended tag or decal.
- If you don't maintain continuous liability insurance coverage on this vehicle, you will be subject to penalties and your vehicle's registration/tag will be suspended.
- A tag is issued to the owner of a vehicle. Please remove the tag if you sell or transfer ownership of this vehicle. A new owner of this vehicle may not use your tag.
- When your insurance company or agent cancels this insurance for a vehicle you sell or transfer, you must cancel the vehicle's tag through your County Tag Office at the same time to avoid insurance lapse penalties.
- When you sell/transfer ownership of a vehicle that is required to be titled, assign the original title to the new owner and give the title to the new owner so the new owner can apply for a title and tag in the county in which he or she lives within seven (7) business days of the sale.



- When you sell/transfer ownership of a vehicle that do not require a title, give the new owner a copy of your registration and a bill-of-sale so that the new owner may apply for a tag in the county in which he or she lives within seven (7) business days of the sale.
